07/22 Apologies received from Cllr. S. Sinclair, Cllr. J. Caesar, Mrs G. Robinson and County Councillor M. Cartwright.

Minutes of the Meeting 9th May

07/23 RESOLVED: That the minutes of the Meeting 9th May 2007, copies of which had been previously circulated, be confirmed and accepted as true records.

Matters Arising From the Minutes

07/24 No matters arose from the Minutes of 9th May 2007.

Election of Staffing Committee

07/25 It was agreed to defer this item until the next meeting, when it is anticipated a full Council will be present to elect a Staffing Committee, whilst in the meantime details of the Clerk's New Model Contract will be circulated to members of the Council for future discussion.

Co-option of New Councillor

07/26 Proposed by N. Davis and seconded by J. Scutt and RESOLVED: That David Caukill be co-opted as Councillor to Hawkley Parish Council.

Adoption of The New Code of Conduct for Councillors

07/27 Proposed by R. Robinson and seconded by N. Davis and RESOLVED: That Hawkley Parish Council adopt the New Code of Conduct including paragraph 12(2) with immediate effect.

New Declaration of Interest Forms (EHDC)

07/28 Following adoption of the New Code of Conduct, new Declaration of Interest Forms were distributed to all present for signature and return directly to EHDC.

Report of the District Councillor

07/29 J. Onslow confirmed problems being experienced in recent weeks with the collection of refuse, were being addressed. J. Onslow advised locals to comment on the new South Downs National Park proposals which exclude the area of the Wield. Regarding the outcome of the recent Gypsy Encampment Appeal, J. Onslow is anticipating a forthcoming meeting with EHDC to consider how to take things forward.

Gypsy Encampment Appeal

07/30 P. Cregeen advised of legal advice received, which strongly advises the Parish Council to maintain pressure on EHDC to provide sites for Gypsies. It was acknowledged that one access to the site has been closed by the occupants, in line with Criteria set out in the Appeal Decision.

Signposts

07/31 P. Cregeen advised of his request to HCC to remove recently installed Brown Signposts, which were erected without prior consultation with the Parish Council. There are also 3 broken white signposts; it was agreed M. Birrell would advise Hampshire Highways.

South Downs National Park

07/32 Following discussion of the proposed exclusion of the Wield in recent new proposals for the SDNP, it was agreed that Hawkley Parish Council would comment in favour

of reinstatement of the Wield in the proposals.

Standfast Lane

07/33 P. Cregeen advised of notification from HCC of intention to carry out works before autumn, to Boat 26 – Standfast Lane, preventing vehicles abusing the path. It was agreed to monitor Tractor access is preserved.

Village Maps

07/34 Up-dated village maps were previously supplied to all members of the Council. Parish boundaries were observed. Owl Box locations were noted.
